BY-LAW # 2008-7

BEING A BY-LAW FOR THE PURPOSE OF ESTABLISHING WINTER ROAD MAINTENANCE STANDARDS

WHEREAS the Council of the Corporation of the Township of Nairn and Hyman deems it expedient and necessary to provide a policy for the standards of winter road maintenance within the municipality.

THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Nairn and Hyman **HEREBY ENACTS AS FOLLOWS:**

1. That the policy attached hereto as Schedule "A" is hereby deemed the policy of the Township with respect to winter road maintenance standards to apply to the whole municipality.
2. That this By-law shall become effective upon third and final reading.
3. That this By-law rescinds by-law number 2002-4 and any other by-law inconsistent of the provisions thereof.

SCHEDULE "A"

For purposes of this policy:

"Urban" shall generally be identified with the geographic Township of Nairn.

"Rural" shall generally be identified with the geographic Township of Hyman.

Snowplowing

Objectives:

- to maintain safe, passable public transportation and school bus routes.
- to facilitate the handling of emergencies by fire, police and ambulance services.
- to reduce the economic losses to the community caused by workers not being able to get to their jobs.

Level of Service:

<u>Urban</u>	<u>Rural</u>

Plowing shall generally be the only treatment accorded to snow packed roads. Sanding of icy areas may be required on steep grades, curves and intersections. Snow plows should be out after a 3 inch accumulation of fresh snow..	Snow plows should be out after a 3 inch accumulation of fresh snow.
Predetermined routes for plowing shall be followed except in critical situations.	Predetermined routes for plowing shall be followed except in critical situations.

- ▶ Parking on municipal streets/roads is prohibited during the hours of 11:00 p.m - 8:00 a.m. or during other periods of snowplowing operations. At the discretion of the Municipal Superintendent, vehicles may be towed away at the owner's expense if it is deemed that they interfere with snowplowing operations.
- ▶ The removal of snow from private driveways onto the road allowance is prohibited, pursuant to Section 181 of the Highway Traffic Act R.S.O. 1990.
- ▶ In the event of freezing rain, equipment will not be out until conditions allow, or in case of emergency (fire, ambulance, police, etc.) all efforts will be made to assist in reaching the destination of the emergency.

Sanding

Objectives:

- to maintain safe passable public transportation and school bus routes.
- to reduce the hazards of icy roads to motorists.
- to facilitate the handing of emergencies by fire, police and ambulance services.

Level of Service:

<u>Urban</u>	<u>Rural</u>
Sanding of steep grades, curves, intersections and railway crossings shall be performed after snow plowing has been completed.	Sanding of steep grades, curves, intersections and railway crossings shall be performed after snow plowing has been completed.
Extra sanding on these areas shall be carried out after freezing rain.	Extra sanding on these areas shall be carried out after freezing rain.
Predetermined routes for sanding shall be followed except in critical situations.	Predetermined routes for sanding shall be followed except in critical situations.

Snow plowing and sanding is to be performed according to the following predetermined routes unless changes are deemed necessary by the Municipal Superintendent.

Predetermined routes for snowplowing and sanding:

1. Smith Street South to McCharles Street West, to Spencer Lane North to Front Street to MacDonald Street East to Highway 17.
2. Taylor Street North.
3. Minto Street from McIntyre to Old Nairn Road.
4. Old Nairn Road.
5. Ferry Street to Water Treatment Plant.
6. Birch Street.
7. Sand Bay Road to and including Dumont Street.
8. Sand Bay Road to Sand Bay Camp to Coal Dock Road.
9. Coal Dock Road.
10. Belle Bay Crescent to and including Baker Drive.
11. Pine Road.
12. Sand Bay Road South from Coal Dock Road to Highway 17.
13. All streets South of Highway 17.
14. All streets North of Highway 17.

Complaints

The Public Works Committee shall act upon a complaint after it has been brought to the Committee in writing and has been signed and dated by the complainant.
